**RESOLUTION TRANSFERRING THE VENUE OF THE SCHEDULED 5<sup>TH</sup> PUBLIC BIDDING ON JULY 28, 2020, THE PRE-BID CONFERENCE FOR THE 6<sup>TH</sup> PUBLIC BIDDING ON JULY 30, 2020, AND THE 6<sup>TH</sup> PUBLIC BIDDING ON AUGUST 11, 2020 FROM THE NEW CAPITOL BUILDING MULTI-PURPOSE HALL TO THE YNARES HALL, THIRD (3<sup>RD</sup>) FLOOR, NEW CAPITOL BUILDING**

**WHEREAS**, the Invitation to Bid for the 5<sup>th</sup> Public Bidding was advertised in the PhilGEPS, LGU website, and in three (3) conspicuous places for the period covering 8 July 2020 to 14 July 2020, for twenty five (25) provincial infrastructure projects in compliance with Republic Act No. 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

**WHEREAS**, the Invitation to Bid for the 6<sup>th</sup> Public Bidding was advertised in the PhilGEPS, LGU website, and in three (3) conspicuous places for the period covering 24 July 2020 to 30 July 2020, for thirty (30) provincial infrastructure projects in compliance with Republic Act No. 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;


**WHEREAS**, the 5<sup>th</sup> Public Bidding for the twenty five (25) infrastructure projects, the Pre-Bid Conference for the 6<sup>th</sup> Public Bidding, and the 6<sup>th</sup> Public Bidding for thirty (30) infrastructure projects were scheduled on 28 July 2020, 30 July 2020, and 11 August 2020 respectively, ALL to be held at the New Capitol Building Multi-Purpose Hall;


**WHEREAS**, due to the increase in the number of positive cases of COVID-19 in the Province of Rizal, a rapid testing for COVID-19 will be conducted by the Rizal Provincial Government thru the Provincial Health Office starting 15 July 2020 at the New Capitol Building Multi-Purpose Hall;

**NOW THEREFORE**, for and in consideration of the foregoing, the Committee **RESOLVED**, as it is hereby resolved, to transfer the venue of the 5<sup>th</sup> Public Bidding to be held on 28 July 2020, the Pre-Bid Conference for the 6<sup>th</sup> Public Bidding to be held on 30 July 2020, and the 6<sup>th</sup> Public Bidding for thirty (30) infrastructure projects to be held on 11 August 2020, from the New Capitol Building Multi-Purpose Hall to the Ynares Hall, Third (3<sup>rd</sup>) Floor, New Capitol Building.


