The Secretary of the Bids & Awards Committee (BAC) presented to the Chairman of the BAC, documents relative to the Construction of 4-storey, 12-room, Ynares School Building at Darangan Elementary School, Barangay Darangan, Binangonan, Rizal;

WHEREAS, the Invitation to Bid was advertised in the PhilGEPS, LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol, Rizal Provincial Hospital-Morong Main and Ynares Sports Center for the period covering 18 December 2018 to 24 December 2018, in compliance with Republic Act 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, on the above-stated date of the bidding, no bids were received;

WHEREAS, Rule X, Section 35 of the 2016 Revised Implementation Rules and Regulations of Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act," state that:

Section 35. Failure of Bidding

35.1. The BAC shall declare the bidding a failure when:

- a) *No bids are received;*

WHEREAS, considering that no bidder submitted bid proposal within the specified time, the members of the BAC decided on the declaration of failure of bidding, in accordance with the above stated provision of the law;

NOW, THEREFORE, for and in consideration of the foregoing, the Committee **RESOLVED**, as it is hereby resolved to recommend to the Honorable Governor the declaration of failure of bidding for the Construction of 4-storey, 12-room, Ynares School Building at Darangan Elementary School, Barangay Darangan, Binangonan, Rizal;

RESOLVED FURTHER, to recommend to the Honorable Governor that a public bidding be again conducted for the above-stated project in compliance with Republic Act 9184.
