**WHEREAS**, the Rizal Provincial Government advertised an Invitation to Bid for the procurement of infrastructure projects from the period of 17 May to 23 May 2021;

**WHEREAS**, the publication covers twenty-seven (27) infrastructure projects with schedule of bid opening on 7 June 2021;
