RESOLUTION CANCELLING THE PUBLICATION AND SUSPENDING THE PUBLIC BIDDING OF THE INFRASTRUCTURE PROJECT TITLED: "CONSTRUCTION OF MULTI-PURPOSE BUILDING AT BRGY. GUITNANG BAYAN I, SAN MATEO, RIZAL" PUBLISHED FROM 7 JUNE TO 13 JUNE 2024 FOR THE OPENING OF BIDS SCHEDULED ON 5 JULY 2024

WHEREAS, the Rizal Provincial Government advertised an Invitation to Bid for the procurement of infrastructure projects from the period of 7 June to 13 June 2024;

WHEREAS, the publication covers ten (10) infrastructure projects with schedule of bid opening/public bidding on 5 July 2024;

WHEREAS, Project No. 9 in the aforementioned publication is entitled: "Construction of Multi-Purpose Building at Brgy. Guitnang Bayan I, San Mateo, Rizal";
