RESOLUTION DISQUALIFYING L. EUSEBIO ACE DEVELOPMENT CORPORATION IN THE PUBLIC BIDDING FOR PROVINCIAL INFRASTRUCTURE PROJECTS HELD LAST 7 JANUARY 2025

WHEREAS, the Rizal Provincial Government through its Rizal Provincial Bids and Awards Committee (RPBAC) held its 1st Public Bidding of CY 2025 on 7 January 2025 for twenty-seven (27) provincial infrastructure projects in compliance with Republic Act No. 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the construction firm *L. Eusebio Ace Development Corporation* participated in the said public bidding for eight (8) of the twenty-seven (27) provincial infrastructure projects;

WHEREAS, L. Eusebio Ace Development Corporation was declared as the bidder with the lowest submitted bid for the following provincial infrastructure projects:

- 3. Construction of Roadway Lightings at Brgy. Bangad and Brgy. Bombong, Binangonan, Rizal;
- 20. Construction of Roadway Lightings at Manila East Road (T. Claudio St.) Brgy. San Juan and Brgy. San Pedro, Morong, Rizal;
- 22. Construction of Roadway Lightings at G. Paz St. (Manila East Road) Brgy. Hulo, Pililla, Rizal;
- 27. Repair/Repainting of Ynares Event Center at Ynares Center Cmpd., Brgy. San Roque, Antipolo City

WHEREAS, L. Eusebio Ace Development Corporation also bidded for the following provincial infrastructure projects but its bid price was not declared as the lowest submitted bid:

- 8. Construction of Roadway Lightings at Brgy. Tatala, Binangonan, Rizal;
- 12. Construction of Roadway Lightings at Brgy. Lambac (Phase 2), Cardona, Rizal;
- Construction of Roadway Lightings at Ynares St., Brgy. Bombongan, Morong, Rizal;
- 24. Construction of Roadway Lightings at A. Luna St., A. Bonifacio, G. Del Pilar St. and A. Mabini St., at Brgy. Quisao, Pililla, Rizal;

WHEREAS, L. Eusebio Ace Development Corporation submitted eligibility and technical documentary requirements including a PhilGEPS Certification indicating the presence of said document;

WHEREAS, upon evaluation of the documentary requirements submitted by L. Eusebio Ace Development Corporation, a deficiency was noted:

PhilGEPS - not updated;

Attached herein is the abovementioned submitted documentary requirement as Annex "A" (PhilGEPS Certification);

WHEREAS, an updated PhilGEPS Certificate of Registration is an eligibility requirement or Class "A" document which must be submitted by prospective bidders to qualify and participate in the public bidding pursuant to R.A. 9184 and Executive Order 398 series of 2005;

NOW THEREFORE, for and in consideration of the foregoing, the Committee RESOLVED, as it is hereby resolved, to disqualify L. Eusebio Ace Development Corporation in the Public Bidding of the Rizal Provincial Government for Provincial Infrastructure Projects held last 7 January 2025.

RESOLVED FURTHER, that copies of this Resolution be furnished to L. Eusebio Ace Development Corporation.

REMINDERS 1

- The PhilGEPS office shall not determine the eligibility of merchants. The PhilGEPS office's evaluation of the eligibility requirements shall be for the sole purpose of determining the approval or disapproval of the merchant's application for registration.
- A merchant's registration and membership in the GOP-OMR is neither contract-specific nor understood to be tantamount to a finding of eligibility. Neither shall the merchant's successful registration in the GOP-OMR be relied upon to claim eligibility for the purpose of participation in any public bidding.
- The determination of the eligibility of merchants, whether registered with the GOP-OMR or not, shall remain with the Bids and Awards Committee (BAC). The BAC's determination of validity of the eligibility requirements shall be conclusive to enable the merchant to participate in the public bidding process.
