WHEREAS, when the submitted bids were read, Sunfu Solutions, Inc. submitted quotation for Item No. 1 (Infant Warmer) in the amount of ₱ 3,680,000.00 and Paco Roman Drug, Inc. submitted a quotation for Item Nos. 1 (Infant Warmer) and 2 (Incubator) in the amount of ₱ 12,500,000.00;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated Sunfu Solutions, Inc.'s quotation for Item No. 1 in the amount of ₱ 3,680,000.00 and Paco Roman Drug, Inc.'s quotation for Item No. 2 in the amount of ₱ 8,700,000.00 appears to be the lowest calculated and responsive bid per item submitted of each of the bidders;

WHEREAS, upon careful examination, validation and verification of the technical component including the eligibility requirements and financial component of the bid submitted by the bidders, all of the documents passed the post qualification conducted after the bid evaluation and such has been found to be responsive;
