WHEREAS, when the submitted bids were read, it appears that **Blu Enterprises** submitted quotation in the amount of ₱54,680.62

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, upon careful examination and evaluation of the submitted bid offer, it was found out that **Blu Enterprises** appears to be the single calculated and responsive price offer for the Consignment of Drugs and Medicines in the amount of ₱ 54,680.62;

WHEREAS, upon careful examination, validation and verification of the eligibility requirements and technical and financial component of the bid submitted by the consignors, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;
