Resolution No. <u>GS2021- 098</u> Series of 2021

WHEREAS, the State of National Emergency is still in effect due to Coronavirus Disease Pandemic that has affected the entire country;

WHEREAS, in response to the urgency and rising number of infected individuals and to give immediate treatment to hospitalized patients with severe COVID19 infection, the Rizal Provincial Government deemed it necessary for the emergency procurement of Remdesivir;

WHEREAS, funds for the purchase of Five Hundred (500) Vials of REMDESIVIR in the amount of ONE MILLION FOUR HINDRED THOUSAND PESOS (P1,400,000.00) shall be chargeable against the General Fund;

WHEREAS, the said purchase shall be made in accordance with the provision of the Implementing Rules and Regulations of Republic Act 9184, otherwise known as the Government Procurement Reform Act, particularly Section 53. Sub. Par. (e), Rule XVI, which states that:

Section 53. Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services, whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant only in the following case:

Section 53.2 Emergency Cases. In case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life property, or to restore vital public services, infrastructure facilities and other public utilities......

NOW THEREFORE, for and in consideration of the foregoing premises, and the provision of 2016 IRR of the Republic Act 9184, otherwise known as the Government Procurement Reform Act, the Committee agrees as they hereby agree to recommend to the Honorable Governor that the procurement of Remdesivir be made through negotiated procurement/emergency cases;
