**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Food Commodities which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 6 August 2021 to 25 August 2021 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P22,969,423.00;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 26 August 2021 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;


**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


1. **TO DECLARE GREEN ENERGY TRADING** as the bidder with the single calculated and responsive bid for the purchase of Food Commodities;
