WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Bituminous Concrete Surface Course which was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Rizal Provincial Hospital-Morong Main and Ynares Sports Center for the period covered 28 January 2021 to 17 February 2021, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P1,500,600.00 ;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is Socor Construction Corp.;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 17 February 2021 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid were found to be substantially complying;


