

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL****Resolution No. GS2022-101  
Series of 2022.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Medical Supplies for use in RPHS - Taytay which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 07 September 2022 to 27 September 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is ₱4,265,500.00;

**WHEREAS**, in response to the said advertisement, seven (7) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, as agreed by the BAC, a Supplemental Bid Bulletin was issued cancelling **Line Item No. 20** in the total amount of ₱ 200,000.00 as it was observed that it is the same with **Item No. 1**;

**WHEREAS**, the bidders' technical component of the bid, including the eligibility requirements were submitted on 28 September 2022 and thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, when the submitted bids were read, it appears that, **Nemrac Medical and Pharma Supplies Inc.** submitted quotation for Item Nos. 1-19, and 21-24 in the amount of ₱2,711,060.00, **Everyday Enterprises** submitted quotation for Item Nos. 1-19 and 21-24 in the amount of ₱2,525,060.00, **Bataan Manufacturing Co., Inc.** submitted quotation for Item Nos. 2, 3, 6, 7, 9, 10, 12, 22 and 24 in the amount of ₱2,358,752.00, **Glore Bio-Medical Corp.**, submitted quotation for Item Nos. 1-5, 7-19, and 21-24 in the amount of ₱1,926,344.00, **Mount Sinai Scientific and Pharma Supply** submitted quotation for Item Nos. 3, 5, 10, 11, and 13-16, in the amount of ₱547,862.00, and **Berovan Marketing, Inc.** submitted quotation for Item No. 3, 4, 11, and 24 in the amount of ₱452,025.00;

**WHEREAS**, the detailed evaluation of the bids was conducted after the opening of bids;

**WHEREAS**, when the submitted bids were evaluated, **Mount Sinai Scientific and Pharmaceutical Supply** submitted quotation for Item Nos. 10, 14, and 15 in the amount of ₱71,012.00, **Berovan Marketing Inc.** submitted quotation for Item Nos. 11 in the amount of ₱78,800.00, **Everyday Enterprise** submitted quotation for Item Nos. 1, 3, 5, and 8 in the amount of ₱208,560.00, **Glore Bio-Medical Corporation** submitted quotation for Item Nos. 9, 12, 13, 16, 18, 19, 22, and 24 in the amount of ₱446,104.00, and **Nemrac Medical and Pharma Supplies** submitted quotation for Item Nos. 2, 4, 6, 7, 17, 21 and 23 in the amount of ₱1,355,140.00. Thus it appears that the above-mentioned quotations are to be the lowest calculated bid per item submitted by each bidder; and



**WHEREAS**, the BAC declared **Everyday Enterprise** post-disqualified for the Procurement of Item No. 11 (Weighing Scale with Height, Platform Type) due to failure to comply with technical specifications as per their Bidding Documents. **Everyday Enterprise's** offer is not compliant with the requirements and conditions set by the end-user as they will only serve as an Original Equipment Manufacturer (OEM). Thus the BAC deemed it necessary to send a Notice of Post-Disqualification to **Everyday Enterprise** for its bid on Item No. 11, pursuant to Sec. 34 of Rule X (Post-Qualification) of RA 9184;

**WHEREAS**, the BAC conducted a Post-Qualification Activity of the Second Lowest Calculated Bidder, **Berovan Marketing Inc.** on 03 October 2022 for the Procurement of Item No. 11 (Weighing Scale with Height, Platform Type), pursuant to the provision of RA 9184 Sec. 34.6 Rule X which states that:

*“34.6 Immediately after the BAC has notified the first bidder of its post-disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the second Lowest Calculated Bid/Highest Rated Bid. If the second bidder passes the post-qualification, and provided that the request for reconsideration of the first bidder has been denied, the second bidder shall be post-qualified as the bidder with the LCRB or HRRB”;*

**NOW THEREFORE**, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

**1. TO DECLARE:**

- 1.1 **MOUNT SINAI SCIENTIFIC AND PHARMACEUTICAL SUPPLY's** quotation for Item Nos. 10, 14, and 15 in the amount of ₱71,012.00;
- 1.2 **BEROVAN MARKETING INC.'s** quotation for Item Nos. 11 in the amount of ₱78,800.00;
- 1.3 **EVERYDAY ENTERPRISE's** quotation for Item Nos. 1, 3, 5, and 8 in the amount of ₱208,560.00;
- 1.4 **GLOREE BIO-MEDICAL CORPORATION's** quotation for Item Nos. 9, 12, 13, 16, 18, 19, 22, and 24 in the amount of ₱446,104.00;
- 1.5 **NEMRAC MEDICAL AND PHARMA SUPPLIES CORP.'s** quotation for Item Nos. 2, 4, 6, 7, 17, 21 and 23 in the amount of ₱1,355,140.00;


as the lowest calculated and responsive bid for the supply and delivery of such laboratory supplies.;




