**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the Purchase of Medical Supplies for the operations of hospitals under the Rizal Provincial Hospital System (RPHS) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS - Morong and RPHS - Angono for the period covered from 16 November 2022 to 05 December 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱5,545,500.00;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid namely, Blu Enterprises;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 06 December 2022. Blu Enterprises was able to satisfy the requirements to participate;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

1. **TO DECLARE BLU ENTERPRISES** as the bidder with the single calculated and responsive bid for the Purchase of Medical Supplies for the operations of hospitals under the Rizal Provincial Hospital System in the amount of ₱5,450,550.00;
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
