

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL.

**Resolution No. GS2022-024
 Series of 2022.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid for the contract for the Hiring of Janitorial Services for Rizal Provincial Hospital System – Margarito A. Duavit Memorial Hospital in the Philippine Government Electronic Procurement System (PhilGEPS), and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Rizal Provincial Hospital-Morong Main and Ynares Sports Center for the period covered 04 February 2022 to 22 February 2022, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P 4,920,000.00;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid namely: Powerminds of Asia, Inc. and Cleanermen Inc.;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 23 February 2022. Cleanermen Inc. was able to satisfy the requirements to participate. However, Powerminds of Asia, Inc. failed to comply with the Bid Security requirement and thereafter declared disqualified to participate in the activity;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 23 February 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Cleanermen, Inc. appears to be the single calculated bid for the contract of Hiring of Janitorial Services for Rizal Provincial Hospital System – Margarito A. Duavit Memorial Hospital in the amount of P 4,905,974.80;

WHEREAS, the new contract with the winning bidder, that is Cleanermen, Inc., will be for a period of ten (10) months only from 01 March 2022 to 31 December 2022.

WHEREAS, the Commission on Audit (COA) has issued a Certificate of Disallowance (COD) against the ABC of P 4,920,000.00 for the contract of Hiring of Janitorial Services for Rizal Provincial Hospital System – Margarito A. Duavit Memorial Hospital.

bid submitted by the bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.

UNANIMOUSLY APPROVED this 28th day of February 2022 at the City of Antipolo, Province of Rizal.


