WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P 3,000,000.00;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid namely: Powerminds of Asia, Inc. and Cleanermen Inc.;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 23 February 2022. Cleanermen Inc. was able to satisfy the requirements to participate. However, Powerminds of Asia, Inc. failed to comply with the Bid Security requirement and thereafter declared disqualified to participate in the activity;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 23 February 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

- TO RECOMMEND for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
