WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱ 3,743,000.00;

WHEREAS, in response to the said advertisement, three (3) suppliers/contractors purchased bid documents and submitted its bid namely: Distinctive Blinds and Office Systems, Inc., MNJ Trading and Starbright Office Depot, Inc.;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 10 August 2022. Distinctive Blinds and Office Systems, Inc. and MNJ Trading were able to satisfy the requirements to participate. However, Starbright Office Depot, Inc. failed to submit their Bid Documents on the time specified in the Invitation to Bid and thereafter declared disqualified to participate in the activity;
