

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**Resolution No. GS2022-115
Series of 2022.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Medical Equipment for use in RPHS - Taytay which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 20 October 2022 to 08 November 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is ₱10,325,000.00;

WHEREAS, in response to the said advertisement, five (5) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 09 November 2022 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, **JCOR Medical Equipment and Supplies Trading** submitted quotation for Item Nos. 1-8 in the amount of ₱10,067,000.00, **Infinite Medical Trading** submitted quotation for Item Nos. 1, and 5-7 in the amount of ₱7,045,000.00, **Nemrac Medical & Pharma Supplies Corp.** submitted quotation for Item Nos. 2-4 and 6-8 in the amount of ₱5,718,500.00, **Robustan Inc.**, submitted quotation for Item Nos. 1 in the amount of ₱3,520,000.00, and **Medical Center Trading Corporation** submitted quotation for Item No. 2 and 5 in the amount of ₱2,248,900.00;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, **Medical Center Trading Corporation** submitted quotation for Item Nos. 5 in the amount of ₱798,900.00, **Nemrac Medical & Pharma Supplies Corp.** submitted quotation for Item Nos. 4 and 7 in the amount of ₱1,280,000.00, **JCOR Medical Equipment and Supplies Trading** submitted quotation for Item Nos. 2, 3 and 8 in the amount of ₱1,950,000.00, **Infinite Medical Trading** submitted quotation for Item Nos. 6 in the amount of ₱2,350,000.00, and **Robustan Inc.** submitted quotation for Item Nos. 1 in the amount of ₱3,520,000.00. Thus it appears that the above-mentioned quotations are to be the lowest calculated bid per item submitted by each bidder; and

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

as the lowest calculated and responsive bid for the supply and delivery of such medical equipment;


2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


