

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF
THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING
APPROVAL**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Laboratory Reagents which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 17 November 2022 to 09 December 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱66,224,480.00;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid namely: Lifeline Diagnostics Supplies Inc. and Scientific Biotech Specialties Inc.;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 12 December 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were read and evaluated, it appears that, **Lifeline Diagnostics Supplies Inc.** submitted its bid for Lots No. 1, 5, and 7 with equivalent sum of ABC for each Lot in the amount of ₱12,145,000.00 and **Scientific Biotech Specialties Inc.** submitted its bid for Lots No. 2, 3, 4, and 6 with equivalent sum of ABC for each Lot in the amount of ₱54,079,480.00;

WHEREAS, **Lifeline Diagnostics Supplies Inc.** appears to be the lowest calculated and responsive bidder for Lots No. 1, 5, and 7 with equivalent sum of ABC for each Lot in the amount of ₱12,145,000.00 and **Scientific Biotech Specialties Inc.** appears to be the lowest calculated and responsive bidder for Lots No. 2, 3, 4, and 6 with equivalent sum of ABC for each Lot in the amount of ₱54,079,480.00.

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. TO DECLARE:


1.1. **Lifeline Diagnostics Supplies Inc.**'s bid for Lots No. 1, 5, and 7 with equivalent sum of ABC for each Lot in the amount of ₱12,145,000.00; and




2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


UNANIMOUSLY APPROVED this 16th day of December 2022, at the City of Antipolo, Province of Rizal.


