WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the Purchase of Two Hundred Three (203) units of Motorcycle with Cargo Type Sidecar which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in **three** (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, RPHS-Angono and RPHS-Morong for the period covered 17 June 2022 to 07 July 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱30,450,000.00;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 08 July 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. **TO DECLARE MCX INTERNATIONAL INC.** as the bidder with the single calculated and responsive bid for the Purchase of Two Hundred Three (203) units of Motorcycle with Cargo Type Sidecar;
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.

UNANIMOUSLY APPROVED this 13th day of July 2022, at the City of Antipolo, Province of Rizal.






