WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid namely: MNJ Trading and Starbright Office Depot;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 03 March 2022. MNJ Trading was able to satisfy the requirements to participate. However, Starbright Office Depot failed to submit the Bid Securing Declaration and the 2019 Income Tax Return (TTR) and thereafter declared disqualified to participate in the activity;

WHEREAS, the bidder's technical and eligibility documents were submitted on 03 March 2022 where bidder was thereafter found to be eligible;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;
