WHEREAS, in response to the said advertisement, three (3) suppliers/contractor purchased bid documents and submitted its bid namely: Robustan Inc., Cosmo Medical Inc. and Nemrac Medical and Pharma Supplies Inc.;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 23 June 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Nemrac Medical and Pharma Supplies Inc. submitted quotation for Item Nos. 1-3 in the amount of P 16,510,000.00, Cosmo Medical, Inc. submitted quotation for Item Nos. 1-3 in the amount of P 16,540,000.00, and Robustan, Inc. submitted quotation for Item Nos. 1-3 in the amount of P 16,660,000.00;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, when the submitted bids were read, it appears that, Nemrac Medical and Pharma Supplies Inc. submitted quotation for Item No. 1 in the amount of P 3,100,000.00, Cosmo Medical, Inc. submitted quotation for Item No. 2 in the amount of P 4,900,000.00, and Robustan, Inc. submitted quotation for Item No. 3 in the amount of P 8,450,000.00 appears to be the lowest calculated bid per item submitted of each bidder;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
