

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2023 - 021  
Series of 2023.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the Purchase of School Bags for distribution to different schools in Montalban and San Mateo Rizal CY 2023 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 13 January 2023 to 01 February 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is Forty Four Million Three Hundred Seven Thousand Eight Hundred Five Pesos (P44,307,805.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Green Energy Trading;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 02 February 2023 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Green Energy Trading appears to be the single calculated and responsive bid for the Purchase of School Bags in the amount of Forty Three Million Six Hundred Thirty Three Thousand Five Hundred Forty Two Pesos and 50/100 (P43,633,542.50);

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


1. **TO DECLARE GREEN ENERGY TRADING** as the bidder with the single calculated and responsive bid for the Purchase of School Bags in the amount of Forty Three Million Six Hundred Thirty Three Thousand Five Hundred Forty Two Pesos and 50/100 (₱43,633,542.50);
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.

**UNANIMOUSLY APPROVED** this 7<sup>th</sup> day of February 2023, at the City of Antipolo, Province of Rizal.




