**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Contract of Hiring of Janitorial Services for Rizal Provincial Capitol Building, Rizal Provincial Capitol Annex, Ynares Event Center and Rizal Provincial Hospital System - Taytay in the Philippine Government Electronic Procurement System (PhilGEPS), and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, RPHS - Morong and RPHS - Angono for the period covered 02 February 2023 to 21 February 2023, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Eleven Million Six Hundred Fifty Seven Thousand Four Hundred Nine Pesos and 83/100 (P11,657,409.83).

**WHEREAS**, the Provision for the Hiring of Janitorial Services was on a per lot basis;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and that is, Powerminds of Asia, Inc.;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 22 February 2023 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Powerminds of Asia, Inc. appears to be the single calculated and responsive bid for the Contract of Hiring of Janitorial Services for Rizal Provincial Capitol Bldg. in the amount of ₱392.10/sqm, Rizal Provincial Capitol Annex in the amount of ₱392.10/sqm, Ynares Event Center in the amount of ₱392.10/sqm, and RPHS Taytay in the amount of ₱782.17/sqm;

**WHEREAS**, the new contracts with the winning bidder, that is Cleanermen, Inc., shall be for ten (10) months covering the period from 01 March 2023 to 31 December 2023.

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


**NOW THEREFORE, WE**, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


1. **TO DECLARE POWERMINDS OF ASIA, INC.** as the bidder with the single calculated and responsive bid for the Hiring of Janitorial Services for **Lot Item Nos. 1, 2, 3, and 4**, to wit:
  - a.) Rizal Provincial Capitol Bldg. in the amount of **Three Hundred Ninety Two Pesos and Ten Centavos per square meter (₱392.10/sqm)**;
  - b.) Rizal Provincial Capitol Annex in the amount of **Three Hundred Ninety Two Pesos and Ten Centavos per square meter (₱392.10/sqm)**;
  - c.) Ynares Event Center in the amount of **Three Hundred Ninety Two Pesos and Ten Centavos per square meter (₱392.10/sqm)**; and
  - d.) RPHS Taytay in the amount of **Seven Hundred Eighty Two Pesos and Seventeen Centavos per square meter (₱782.17/sqm)**.
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
