

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF  
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING  
APPROVAL****Resolution No. GS2022- 129  
Series of 2022**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Treatment and Transport of Hazardous Waste for the hospitals under the Rizal Provincial Hospital System (RPHS) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 17 November 2022 to 09 December 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱6,220,000.00 or ₱32.00/kilo;

**WHEREAS**, in response to the said advertisement, two (2) supplier/contractor purchased bid documents namely: Cleanhaul Environmental Services Inc. and Servo-Treat Philippines Inc. but only one (1) supplier/contractor submitted its bid and that is Cleanhaul Environmental Services Inc.;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 12 December 2022 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Cleanhaul Environmental Services Inc. appears to be the single calculated bid for the Treatment and Transport of Hazardous Waste in the amount of ₱31.00/kilo;

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder. the documents passed the post-qualification conducted after the bid

**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. **TO DECLARE CLEANHAUL ENVIRONMENTAL SERVICES INC.** as the bidder with the single calculated and responsive bid for the Treatment and Transport of Hazardous Waste in the amount of ₱31.00/kilo;
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.

**UNANIMOUSLY APPROVED** this 16<sup>th</sup> day of December 2022, at the City of Antipolo, Province of Rizal.




