WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million Seven Hundred Thousand Pesos (\$\mathbb{P}2,700,000.00);

WHEREAS, in response to the said advertisement, four (4) suppliers/contractors purchased bid documents and submitted its bid, namely: First Philippine Scales, Inc., Universal Commercial Corporation, Myrna Oliva Enterprises, and Hinoki Global Concepts, Inc.;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 22 August 2023. First Philippine Scales, Inc., Universal Commercial Corporation, and Myrna Oliva Enterprises were able to satisfy the requirements to participate. However, Hinoki Global Concepts, Inc. failed to submit their Audited Financial Statement (AFS) for the year 2021 – hence, applying the pass/fail criteria, was declared disqualified to participate in the activity.

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- 1. TO DECLARE FIRST PHILIPPINE SCALES, INC. as the bidder with the lowest calculated and responsive bid for the Purchase of Weighing Scale in the amount of Eight Hundred Ninety Nine Thousand Two Hundred Fifty Pesos (\$\mathbb{P}899,250.00);
- 2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
