WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Three Million Five Hundred Seventy Six Thousand Three Hundred Nineteen Pesos (₱3,576,319.00);

WHEREAS, in response to the said advertisement, four (4) suppliers/contractors purchased bid documents and submitted its bid, namely: Allied Hospital Supply International Corporation, Nemrac Medical and Pharma Supplies Corporation, Scientific Biotech Specialties, Inc., and Medical Center Trading Corporation;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 18 July 2023 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Nemrac Medical and Pharma Supplies Corporation submitted quotation for Item Nos. 2-29 and 31 in the amount of Two Million Six Hundred Ninety Thousand Two Hundred Seventy Five Pesos and Eighty Centavos (\$\mathbb{P}2,690,275.80)\$, Medical Center Trading Corporation submitted quotation for Item Nos. 1, 3, 8, 10, 11, 15-22, 26-29 and 31 in the amount of One Million Two Hundred Fourteen Thousand Nine Hundred Thirty Seven Pesos and Sixty Centavos (\$\mathbb{P}1,214,937.60)\$, Scientific Biotech Specialties, Inc. submitted quotation for Item No. 30 in the amount of Eight Hundred Thirty Eight Thousand Three Hundred Ninety Pesos (\$\mathbb{P}838,390.00)\$, and Allied Hospital Supply International Corporation submitted quotation for Item Nos. 6, 7 and 14 in the amount of Five Hundred Seventy Eight Thousand Sixty Pesos (\$\mathbb{P}578,060.00)\$;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, Allied Hospital Supply International Corporation submitted quotation for Item Nos. 6, 7 and 14 in the amount of Five Hundred Seventy Eight Thousand Sixty Pesos (\$\mathbb{P}\$578,060.00), Scientific Biotech Specialties, Inc. submitted quotation for Item No. 30 in the amount of Eight Hundred Thirty Eight Thousand Three Hundred Ninety Pesos (\$\mathbb{P}\$838,390.00), Nemrac Medical and Pharma Supplies Corporation submitted quotation for Item Nos. 2-5, 9, 12, 13, 18 and 23-25 in the amount of Eight Hundred Ninety One Thousand Six Hundred Forty Two Pesos (\$\mathbb{P}\$891,642.00) and Medical Center Trading Corporation submitted quotation for Item Nos. 1, 8, 10, 11, 15-17, 19-22, 26-29 and 31 in the
