

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of three (3) units of Patrol Motorcycle for the use of Provincial Security Division/Governor's Office which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS – Angono and RPHS - Morong for the period covered 22 February 2023 to 13 March 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is One Million Eight Hundred Sixty Thousand Pesos (₱1,860,000.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 14 March 2023 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. **TO DECLARE MCX INTERNATIONAL, INC.** as the bidder with the single calculated and responsive bid for the Purchase of three (3) units of Patrol Motorcycle in the amount of One Million Eight Hundred Fifty Eight Thousand Five Hundred Pesos (₱1,858,500.00);
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




