

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2023-096  
Series of 2023.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Medical Supplies for use in Peritoneal Dialysis at RPHS – Margarito A. Duavit Memorial Hospital which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS - Morong and RPHS - Angono for the period covered from 26 June 2023 to 17 July 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Nineteen Million Five Hundred Fifty Thousand Nine Hundred Three Pesos (₱19,550,903.00);

**WHEREAS**, in response to the said advertisement, eight (8) suppliers/contractors purchased bid documents and submitted its bid;

**WHEREAS**, the bidders' technical component of the bid, including the eligibility requirements were submitted on 18 July 2023 and thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, when the submitted bids were read, it appears that, **Rite-Tech Marketing** submitted a quotation for Item Nos. 17-19, 26-33, 64-69, and 79-82 in the amount of Two Million Seven Hundred Twelve Thousand Five Hundred Nine Pesos and Fifty Centavos (₱2,712,509.50), **Medical Center Trading Corporation** submitted a quotation for Item Nos. 26-33, 45-47, 49, 50 and 84 in the amount of Six Million Two Hundred Twenty Two Thousand Four Hundred Two Pesos (₱6,222,402.00), **Mount Sinai Scientific and Pharmaceutical Supply** submitted a quotation for Item No. 8-16, 20-24, 26-34, 41-44, 48-50, 53, 58, 62, 63, 84, and 89-96 in the amount of Seven Million One Hundred Ninety Eight Thousand Six Hundred Twenty Six Pesos and Ten Centavos (₱7,198,626.10), **Blu Enterprises** submitted a quotation for Item Nos. 1, 8-12, 14-16, 21-24, 26-41, 48-51, 53, 54, 56-60, 76, 78, 83-93, and 98-100 in the amount of Eight Million Three Hundred Fourteen Thousand One Hundred Nine Pesos and Eighty Centavos (₱8,314,109.80), **Nemrac Medical and Pharma Supplies Corporation** submitted a quotation for Item Nos. 1-46, 48-69, 75-100, and 104 in the amount of Thirteen Million Six Hundred Five Thousand Six Hundred Ninety Eight Pesos and Twenty Centavos (₱13,605,698.20), **Strength Medical and Drug Supply** submitted a quotation for Items No. 1-4, 6-20, 22-24, 26-46, 48-60, 62-76, and 78-104 in the amount of Sixteen Million Nine Hundred Seventy Nine Thousand Fifty Five Pesos and Twenty Centavos (₱16,979,055.20), **Gloree Bio-Medical Corporation** submitted a quotation for Items No. 1-46 and 48-104 in the amount of Seventeen Million One Hundred Eleven Thousand Six Hundred Fifty Three Pesos and Fifty Five Centavos (₱17,111,653.55), and **JCOR Medical Equipment and Supplies Trading** submitted a quotation for Item Nos. 1-46 and 48-104 in the



WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, it appears that **Mount Sinai Scientific and Pharmaceutical Supply** submitted its bid in the amount of One Million Two Hundred Two Thousand Eight Hundred Sixty Eight Pesos (P1,202,868.00), **JCOR Medical Equipment and Supplies Trading** submitted its bid in the amount of One Million Four Hundred Fourteen Thousand Seven Hundred Thirty Five Pesos and Fifty Centavos (P1,414,735.50), **Gloree Bio-Medical Corporation** submitted its bid in the amount of One Million Four Hundred Sixty Five Thousand Three Hundred Thirty Pesos (P1,465,330.00), **Nemrac Medical and Pharma Supplies Corporation** submitted its bid in the amount of One Million Nine Hundred Five Thousand Six Hundred Seventy Three Pesos and Fifty Centavos (P1,905,673.50), **Medical Center Trading Corporation** submitted its bid in the amount of Two Million Five Hundred Forty Three Thousand Three Hundred Twenty Five Pesos (P2,543,325.00), **Rite-Tech Marketing** submitted its bid in the amount of Two Million Five Hundred Sixty Two Thousand Four Hundred Seventy Five Pesos (P2,562,475.00), **Strength Medical and Drug Supply** submitted its bid in the amount of Three Million Five Hundred Thirty Nine Thousand Three Hundred Twenty Six Pesos (P3,539,326.00), and **Blu Enterprises** submitted its bid in the amount of Four Million Five Hundred Sixteen Thousand Five Hundred Forty Two Pesos (P4,516,542.00) (Bid Evaluation is hereto attached for ready reference);

WHEREAS, the BAC declared **Mount Sinai Scientific and Pharmaceutical Supply** post-disqualified for the Procurement of Item No. 42 (Hypodermic Needle, g 26, 100's) due to their failure to comply with the requirements stated on the Checklist of Technical and Financial Documents. The latter failed to submit their Product Evaluation for the aforementioned item. Thus the BAC deemed it necessary to send a Notice of Post-Disqualification to **Mount Sinai Scientific and Pharmaceutical Supply** for its bid on Item No. 42, pursuant to Sec. 34 of Rule X (Post-Qualification) of RA 9184;

WHEREAS, the BAC conducted a Post-Qualification Activity of the Second Lowest Calculated Bidder, in favor of **Gloree Bio-Medical Corporation** on 25 July 2023 for the Procurement of Item No. 42 (Hypodermic Needle, g 26, 100's), pursuant to the provision of RA 9184 Sec. 34.6 Rule X which states that:

*"34.6 Immediately after the BAC has notified the first bidder of its post-disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the second Lowest Calculated Bid/Highest Rated Bid. If the second bidder passes the post-qualification, and provided that the request for reconsideration of the first bidder has been denied, the second bidder shall be post-qualified as the bidder with the LCRB or HRRB";*

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. TO DECLARE:

- 1.1 **Mount Sinai Scientific and Pharmaceutical Supply's** quotation for Item Nos. 14-16, 20, 44, 48, 53, 58, 62, 63, and 89-93 in the amount of One Million Two Hundred Two Thousand Eight Hundred Sixty Eight Pesos (P1,202,868.00);
- 1.2 **JCOR Medical Equipment and Supplies Trading's** quotation for Item Nos. 2, 4, 5, 25, 40, 43, 52, 60, 61, 75, 94-96, and 101 in the amount of One Million Four Hundred Fourteen Thousand Seven Hundred Thirty Five Pesos and Fifty Centavos (P1,414,735.50);



- 1.3 **Glore Bio-Medical Corporation's** quotation for Item Nos. 6-13, 23, 35-39, 42, 50, 55, 76, 78, 87, 88, 97, and 100 in the amount of One Million Four Hundred Sixty Five Thousand Three Hundred Thirty Pesos (₱1,465,330.00);
- 1.4 **Nemrac Medical and Pharma Supplies Corporation's** quotation for Item Nos. 3, 21, 24, 51, 59, 77, 85, 86, 98, 99, and 104 in the amount of One Million Nine Hundred Five Thousand Six Hundred Seventy Three Pesos and Fifty Centavos (₱1,905,673.50);
- 1.5 **Medical Center Trading Corporation's** quotation for Item Nos. 45-47 in the amount of Two Million Five Hundred Forty Three Thousand Three Hundred Twenty Five Pesos (₱2,543,325.00);
- 1.6 **Rite-Tech Marketing's** quotation for Item Nos. 17, 18, 19, 64-69, and 79-82 in the amount of Two Million Five Hundred Sixty Two Thousand Four Hundred Seventy Five Pesos (₱2,562,475.00);
- 1.7 **Strength Medical and Drug Supply's** quotation for Item Nos. 70-74 and 102-103 in the amount of Three Million Five Hundred Thirty Nine Thousand Three Hundred Twenty Six Pesos (₱3,539,326.00); and

as the lowest calculated and responsive bid for the supply and delivery of such medical supplies.

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.






