

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF
THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING
APPROVAL**

**Resolution No. GS2023-066

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Laboratory Supplies for the operations of Rizal Provincial Hospital System (RPHS) - Taytay which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS-Angono and RPHS-Morong for the period covered 03 April 2023 to 24 April 2023, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million Thirty Eight Thousand Four Hundred Ten Pesos (₱2,038,410.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 25 April 2023 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, **Nemrac Medical and Pharma Supply Corporation** submitted quotation for Item Nos. 1-65 in the amount of One Million Seven Hundred Eighty Three Thousand Seven Hundred Eighty One Pesos and Sixty Centavos (₱1,783,781.60) and **Gloree Bio-Medical Corporation** submitted quotation for Item Nos. 1-65 in the amount of One Million Seven Hundred Eighty Two Thousand Six Hundred Twelve Pesos and Forty Centavos (₱1,782,612.40);

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, **Gloree Bio-Medical Corporation** submitted quotation for Item Nos. 1-3, 5, 6, 9, 11, 12-14, 18, 19, 21, 22, 24, 29-35, 37, 38, 40, 47-52, 58-60, 63 and 65 in the amount of Seven Hundred Seventy Six Thousand Seven Hundred Fifty Four Pesos (₱776,754.00) and **Nemrac Medical and Pharma Supply Corporation** submitted quotation for Item Nos. 4, 7, 8, 10, 15-17, 20, 23, 25-28, 36, 39, 41-46, 53-57, 61, 62 and 64 in the amount of One Million Four Thousand Forty One Pesos and Eighty Centavos (₱1,004,041.80). Thus it appears that each bidder's submitted quotations for the items are the lowest calculated bid as a result.

as the lowest calculated and responsive bid for the supply and delivery of such laboratory supplies.


2. TO RECOMMEND for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


