WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, Gloree Bio-Medical Corporation submitted quotation for Item Nos. 1-3, 5, 6, 9, 11, 12-14, 18, 19, 21, 22, 24, 29-35, 37, 38, 40, 47-52, Pesos (P776,754.00) and Nemrac Medical and Pharma Supply Corporation submitted quotation for Item Nos. 4, 7, 8, 10, 15-17, 20, 23, 25-28, 36, 39, 41-46, 53-57, 61, 62 and 64 in the amount of that each bidder's submitted quotations for the items are the lowest calculated bid as a result.
