WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Hiring of Buses for the 2023 CALABARZON Heroes Games (Regional Sports Competition) in the Philippine Government Electronic Procurement System (PhilGEPS), and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, RPHS - Morong and RPHS - Angono for the period covered 24 February 2023 to 15 March 2023, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million One Hundred Thousand Pesos (₱2,100,000.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and that is, Rockred Corporation and A&W Tours and Transport Corporation;

WHEREAS, the Rockred Corporation's technical component of the proposal, including the eligibility requirements were submitted on 16 March 2023 and was thereafter found to be eligible. However, A&W Tours and Transport Corporation, submitted an expired PhilGEPS Registration Certificate and thereafter declared disqualified to participate in the activity;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;




NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED:**



2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




