

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2023-116  
 Series of 2023.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Garbage Trike for distribution as incentive to different barangays within the Province of Rizal, in line with their active participation to YES to Green Program. which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS – Angono and RPHS - Morong for the period covered 29 August 2023 to 18 September 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, under Bids and Awards Committee (BAC) Resolution No. GS2023-107 Series 2022, the Rizal Provincial Government previously conducted a procurement activity for the above-named project. However, the BAC declared a failure of bidding as no prospective bidders submitted the required documents on the first invitation/advertisement. Thus the procurement activity for the same project was posted and re-advertised for the second time;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million Nine Hundred Seventy Thousand Pesos (₱2,970,000.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, World Solution Technology, Inc.;

**WHEREAS**, the bidder’s technical component of the proposal, including the eligibility requirements were submitted on 18 September 2023 and was thereafter found to be eligible;

**WHEREAS**, the bidder’s financial component of the bid was found to be substantially complying;

1. **TO DECLARE WORLD SOLUTION TECHNOLOGY, INC.** as the bidder with the single calculated and responsive bid for the Purchase of Garbage Trike in the amount of Two Million Nine Hundred Twenty Five Thousand Pesos (₱2,925,000.00);
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




