**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Rescue Vehicle for distribution to Disaster Risk Reduction and Management Office (DRRMO) of city and municipalities within the Province of Rizal which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong, RPHS- Angono for the period covered 18 April 2024 to 08 May 2024 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Eighteen Million Two Hundred Thousand Pesos (₱ 18,200,000.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Evolander Motor Corp.;

**WHEREAS**, the bidder’s technical component of the proposal, including the eligibility requirements were submitted on 09 May 2024 and was thereafter found to be eligible;

**WHEREAS**, the bidder’s financial component of the bid was found to be substantially complying;


**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


