

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2024- 141
Series of 2024.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Provision of Detainee's Subsistence for the Rizal Provincial Jail (RPJ) which was posted in the Philippine Government Electronic Procurement System (PhilGEPs), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 21 November 2024 to 10 December 2024 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Four Million Three Hundred Eighty Thousand Pesos (₱ 4,380,000.00) or One Hundred Pesos (₱ 100.00) per head/day;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Green Energy Trading;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 11 December 2024 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Green Energy Trading appears to be the single calculated and responsive bid for the Provision of Detainee's Subsistence in the amount of Ninety Nine Pesos and Fifty Centavos (₱ 99.50) per head/day;



1. **TO DECLARE GREEN ENERGY TRADING** as the bidder with the single calculated and responsive bid for the **Provision of Detainee's Subsistence** in the amount of **Ninety Nine Pesos and Fifty Centavos (₱ 99.50) per head/day;**
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




