**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Additional Equipment and supplies/consumables for Rehabilitation Unit of Rizal Provincial Hospital System (RPHS) - Taytay and RPHS – Casimiro A. Ynares Sr. Memorial Hospital (CAYSMH) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 28 February 2024 to 18 March 2024, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million Seven Hundred Fifty Thousand Pesos (₱ 2,750,000.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid and that is, Lafayette Pharmaceuticals;

**WHEREAS**, the bidder’s technical component of the bid, including the eligibility requirements were submitted on 19 March 2024 and thereafter found to be eligible;

**WHEREAS**, the bidder’s financial component of the bid was found to be substantially complying;
