

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Provision of Food for the Regional Athletic Association Meet (RAAM) Competition Proper on March 4-13, 2026 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 04 February 2026 to 23 February 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Four Million Seven Hundred Sixteen Thousand Pesos (₱ 4,716,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor submitted its bid, that is, VND Enterprises;

WHEREAS, the bidder’s technical component of the bid, including the eligibility requirements were submitted on 24 February 2026 and thereafter found to be eligible;

WHEREAS, the bidder’s financial component of the bid was found to be substantially complying;

1. **TO DECLARE VND ENTERPRISES** as the bidder with the single calculated and responsive bid for the **Provision of Food for the Regional Athletic Association Meet (RAAM) Competition Proper on March 4-13, 2026** in the amount of **Four Million Six Hundred Ninety Two Thousand Four Hundred Twenty Pesos (₱4,692,420.00)**; and,
